**ORDINANCE NO. 03 - 2011**

**ORDINANCE AMENDING CHAPTER 135 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVERDALE**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Riverdale, in the County of Morris and State of New Jersey, as follows:

**Section 1.** Chapter 135 of the Revised General Ordinances of the Borough of Riverdale shall be amended by the following revision to Section 135-3, which shall read in its entirety as follows:

**§ 135-3.** The use of the Senior Community Center or The Glenburn Estate by a private group, organization, or individual shall be limited to Borough residents only. A security deposit in the amount of Five Hundred (\$500.00) Dollars shall be required from any private group, organization, or individual utilizing the Senior Center or The Glenburn Estate. The non-refundable user fees for the Senior Community Center and The Glenburn Estate are:

Residents' Private Use	\$55.00
Civic and Non-Profit Organizations	\$55.00 for meetings with up to 100 attendees \$75.00 for meetings with more than 100 attendees \$75.00 - \$100.00 for public events \$100.00 - \$150.00 for public events with food served
Commercial/Business Organizations	\$120.00 for meetings/seminars \$150.00 for public events up to 100 attendees \$200.00 for public events with more than 100 attendees

There shall be an additional fee of \$20.00 towards the Defibrillator Fund with each rental.

**Section 2.** If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**Section 3.** All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

**Section 4.** This Ordinance shall take effect immediately after final passage and publication in the manner provided by law.
