ORDINANCE NO. 7 - 2008

ORDINANCE AMENDING CHAPTER 95 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVERDALE AND PROVIDING FEES FOR USE OF POLICE SERVICES BY OUTSIDE CONTRACTORS

BE IT ORDAINED by the Mayor and Council of the Borough of Riverdale, in the County of Morris and State of New Jersey, as follows:

Section 1. Chapter 95 of the Revised General Ordinances of the Borough of Riverdale, Section 95-15 entitled "Use by outside contractors" shall be amended to read in its entirety as follows:

ARTICLE VII Fees for Police Services

§ 95-15. Use by outside contractors.

- A. The charge for use of police officers by outside contractors shall be the sum of \$100 per hour for police officers on regular time and a half and \$120 per hour for holidays and when police officers are entitled to double time. Police officers shall be assigned to the contractor by the Chief of Police for services as approved by the Chief of Police.
- B. Contractors wishing to utilize the services of the Borough of Riverdale Police Department shall be required to enter into an agreement promulgated by the Borough Clerk which shall include a requirement that if a bill remains unpaid for a period of over 30 days after mailing or presentment, interest of 8% per annum will be charged on accounts up to \$1,500 and 10% per annum on delinquent accounts over \$1,500. In addition, any delinquency in excess of \$10,000 not paid by the end of the fiscal year will be charged a penalty of 6%.

Section 2. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 3. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 4. This Ordinance shall take effect immediately after final passage and publication in the manner provided by law.
